The award consists of two components: The top design features 12 etched crystal planes, layered to convey the kinetic energy of an engaged workforce. The crystal sits atop a concave-shaped pedestal base composed of polished silver-plated legs and a satin finish front display. The combination of these parts results in a piece that evokes the nature of engagement.
