Douglas Emmett Obtains Ten Year, \$102 Million Term Loan Fixed At 2.84%

(NYSE:DEI), a real estate investment trust (REIT), announced that it closed a non-recourse \$102 million term loan fixed at 2.84% for five years, due in April 1, 2025. The loan is secured by Douglas Emmett's recently acquired Waena Apartments, a 468 unit multifamily community located in Honolulu within walking distance of the Central Business District. Interest on the loan is based on Libor plus 1.25%. No principal payments are due until the loan matures in April 2025.
