# INTRODUCTION

As part of our commitment to be a safe and responsible business, we want to lead and challenge global aviation towards net zero carbon emissions while positively impacting our communities and our people. We recognise the need to transition to a low carbon economy and will continue to work towards ensuring that aviation plays its part. This policy sets out our approach to manage and minimise our environmental impacts.



# SCOPE AND GOVERNANCE

This policy applies to the management and operation of easyJet plc and its airline subsidiary businesses, easyJet Airline Company Limited, easyJet Europe Airline GmbH, easyJet Switzerland S.A and easyJet UK Limited. 'easyJet' means this group of companies. easyJet operates over 350 aircraft flying 1279 routes to more than 166 airports in 38 countries.\*

This policy applies to all easyJet staff, permanent, temporary and third parties. It includes all activities at our head office and other locations, aircraft crew bases, and aircraft engineering and maintenance facilities throughout the UK, Europe and our wider network.

# OUR AIMS AND COMMITMENTS

**easyJet is committed to demonstrating environmental leadership through its operations. We aim to:**

- Achieve net zero by 2050
- Meet our environmental compliance obligations
- Monitor and minimise the use of energy and natural resources, managing our consumption efficiently and effectively
- Monitor and minimise the carbon emissions produced for each kilometre travelled by our passengers, minimising fuel usage and associated carbon emissions through efficiency measures
- Apply the waste hierarchy and minimise waste generated across our operations, recycle and divert from landfill as much as possible
- Reduce as much single use plastic as we can
- Work collaboratively with airports to reduce the impact of both aircraft and aerodrome noise on communities who live near airports or under flight paths
- Work collaboratively with airports to improve the efficiency of our facilities
- Support the development of new technologies both in the air and on the ground – including hybrid-electric and hydrogen-powered aircraft and equipment
- Work closely and collaboratively with both Original Equipment Manufacturers and Maintenance & Repair Organisations in support of clean and efficient manufacturing and overhaul
- Strive to protect the environment, seek to prevent pollution, and to continuously improve our environmental performance



# HOW WILL WE DO THIS

**Our environment policy is an integral part of easyJet and will be integrated into all aspects of our business. To achieve our aims:**

- We will develop and implement environment, fuel and energy strategies and programmes to deliver on this policy
- We will regularly monitor our environmental performance with key targets and metrics
- We will continue to invest in efficiency measures to minimise fuel usage and carbon emissions
- We will maintain certification to the IATA IEnvA environmental management standard which is aligned to ISO 14001. The scope of easyJet's certification covers flight operations, corporate buildings, maintenance repair and overhaul.
- We will try to eliminate non-essential plastic, move from single use to reusable alternatives where feasible and engage our value chain for a better design and ease of recycling
- We will eliminate non-essential and unnecessary consumable materials within the aircraft cabin
- We will look for opportunities to minimise the impacts from our properties and facilities
- We will provide information, training and support to our employees, and will inform our business partners and suppliers to be aware of,

uphold and influence our environmental commitments and create a wider appreciation of sustainability issues

- We will increase leadership involvement and employee engagement in improving our environmental performance
- We will work with our stakeholders and interested parties to encourage better environmental performance
- We will regularly report on our environmental performance on our website and in our annual report
- We will deliver on-going environmental management improvements including reviewing this policy and its effectiveness at least on an annual basis



# ACCOUNTABILITY AND RESPONSIBILITY

The Airline Management Board has overall responsibility for implementing this policy. Day-to-day responsibility for implementing this policy, monitoring its use and effectiveness and dealing with any queries is delegated to the Chief Operating Officer.
