SCOPE



easyJet's suppliers have an important role in delivering our ambition, and we strive to ensure that our suppliers have aligned views on Corporate Responsibility and compliance. On the next page is easyJet's Supplier Code of Conduct, which all of easyJet's suppliers must follow.

If you plan to use subcontractors to deliver some or all of the services to easyJet (and where our approval is necessary), you must ensure they follow this Code of Conduct. You can achieve this by including a clause in your subcontract agreements that requires your subcontractors to adhere to this Code.

SUPPLIER CODE OF CONDUCT

- Supplier shall comply with all laws applicable to it and its operations. Where the requirements of such applicable laws and this Code differ, or are in conflict, the Supplier shall comply with the highest standard consistent with applicable laws.
- 2. Supplier shall provide clean, safe and healthy working conditions for its employees, agents and contractors, including by implementing a health and safety policy.
- Supplier shall ensure fair treatment, equality of 3. opportunity and diversity in the workplace in terms of recruitment, progression, remuneration and conditions of work, irrespective of gender, race, colour, language, disability, political opinion, age, religion, or national or social origin.

- Supplier shall ensure that workers are treated with respect and dignity, and it shall not tolerate any degrading treatment towards workers, such as mental or sexual harassment, discriminatory gestures, language or physical contact that is sexual, coercive, threatening, exploitative.
- 5. Supplier shall allow consultative work-place structures and associations which provide employees with an opportunity to present their views to management.
- Supplier shall respect internationally recognised 6. human rights, including those expressed in the United Nations International Bill of Human Rights, and the internationally recognised rights and principles set out in the International Labour Organisation's Core Conventions, Protocols and

Declaration on Fundamental Principles and Rights at Work.

- Supplier shall conduct its business consistently 7. with the United Nations Guiding Principles on Business and Human Rights.
- Supplier shall, by reference to the standards 8. referred to in this code;
 - > strictly prohibit any form of slavery, exploitation, child abuse, or human trafficking in its operations and supply chain in relation to any person. It shall not employ or use any form of illegal child labour, forced, bonded or compulsory labour.

- > strictly prohibit the use of any premises under its control, including hotel or self- catering accommodation and transportation of any kind, in relation to the exploitation or trafficking of any person, whether or not they are an employee of the supplier.
- > Where reasonably required, Supplier shall at all times have a written policy in relation to such matters and shall ensure the policy's effective implementation within its organisation.
- 9. Supplier shall comply with all applicable in-country anti-bribery, anti-corruption and anti-fraud laws and regulations, including adhering to the UK Bribery Act (2010). The supplier shall not solicit, accept, offer, provide or authorise bribes of any kind, either directly, or indirectly, and shall not make illegal facilitation payments or kickbacks. Supplier shall not make any payments or give anything of value (including gifts or hospitality) to any person in connection with easyJet's business in order to improperly influence any person.

Supplier effective shall maintain antibribery/corruption and anti-fraud programmes designed to ensure compliance with applicable anti-corruption laws and regulations.

- 10. Supplier shall ensure that any gifts or hospitality offered or received by its employees or contractors, or in any way connected with easyJet's business, are reasonable, and not likely to be perceived as intended to influence business decisions or to obtain a business advantage. If no Policy exists, the supplier shall follow easyJet's Policy limits.
- Supplier shall be firmly opposed to all forms of 11 money laundering and shall only conduct business with partners involved in legitimate business activities with funds derived from legitimate sources. Supplier shall take steps to prevent and detect any illegal form of payments and prevent its transactions from being used by others to launder money.

12. Supplier shall be firmly opposed to all forms of tax evasion and shall conduct business so as to be compliant with applicable tax laws. Supplier shall not, and shall take appropriate steps to ensure its employees, partners and third parties that act for the Supplier do not, facilitate tax evasion.

13. Supplier shall take steps to ensure that no entity or person subject to United Nations¹ European Union^{2,} UK³ or other applicable sanctions laws and regulations. (the "Sanctions") is involved in or unlawfully benefits from the Supplier's operations, including its supply chain, and to prevent involvement in any transaction prohibited by applicable sanctions laws and regulations. The Supplier has implemented, maintains and enforces

adequate policies and procedures (including systems and controls) designed to ensure compliance with the Sanctions, by the Supplier and its directors, officers, employees or agents.

- **14.** Neither the Supplier nor any person or entity which owns or controls (directly or indirectly) the Supplier is subject to Sanctions.
- **15.** The Supplier is not subject to any investigation or enforcement action (including the imposition of fines or penalties) by any governmental, administrative, regulatory or similar body or authority in any jurisdiction in each case relating to, or in connection with, any actual or alleged contravention of Sanctions.

- 16. Supplier shall ensure that its private interests (e.g. politics/religion/family/other business interests) do not interfere or compete with its contractual or other obligations to easyJet and will promptly put its easyJet business contact on notice of any interest which conflicts with the interests of easyJet at any time that this becomes apparent.
- 17. Supplier shall interact with competitors in an honest and professional manner, and not cause or be part of any breach of applicable competition laws and regulations, such as illegal cooperation on pricing and illegal market sharing.
- 18. Supplier shall encourage the efficient use of energy, water and materials, natural resources, promote the protection of the environment, preserve biodiversity, seek to prevent pollution and other environmental harm, work to reduce its environmental impact and minimise waste.

Supplier Code of Conduct

- 19. Supplier shall measure and report on their carbon footprint, and work to reduce their impact on climate change, take actions to adapt to climate change and consider its exposure to climate-related risk.
- 20. Supplier shall support the social and economic wellbeing of local communities in respect of local traditions, customs, cultures and law and take account of the impact of its operations on the local community.
- Supplier shall promote sustainable 21. The procurement practices and operations among its supplier base and integrate environmental issues into their supply chain management.

22. Supplier shall ensure that where it has access to easyJet premises and/or systems, it is aware of and has or will implement appropriate measures to protect against Insider Threats and shall engage with easyJet where any Insider Threat issue is identified.
