- Work with members of the Engineering team to ensure that the mine plan is followed in an effective and productive manner.

- Coordinate with the Mining Department regularly to ensure that stope designs and development layouts are created accurately and in a timely manner.

- Confer with the ventilation and ground control teams to ensure that all necessary vent planning and infrastructure is incorporated in the plan.
