

TERMS OF USE

Please read these Terms of Use before using the Site (as defined below). Your access to and use of the Site is subject to these Terms of Use and all applicable laws and regulations. The Terms of Use constitute a legal agreement between you and Sound Point (as defined below). The Site is available only to, and may only be used by, individuals who can form legally binding contracts under applicable law. Without limiting the foregoing, the Site is not available to persons under age 18. This Site is owned and operated by Sound Point and is being provided to you under the following terms and conditions and any operating rules, policies, and procedures that may be published from time to time on this Site by Sound Point (collectively, the "Terms of Use").

These Terms of Use govern visitors' ("Visitors") access to and use of the public areas of the Site that are available to all Visitors ("Public Areas").
