"This investment will go a long way toward solidifying our long-term presence in Sherbrooke," said Aurelio Calabretta, Vice President & General Manager for Smucker Foods of Canada. "Through this initiative, we will be able to introduce new packaging capabilities previously unavailable to us in Canada."
