



U.S. Bank announces quarterly dividends

MINNEAPOLIS--(BUSINESS WIRE)--Sep. 15, 2020-- The Board of Directors of U.S. Bancorp (NYSE: USB) has declared a regular quarterly dividend of \$0.42 per common share, payable October 15, 2020, to stockholders of record at the close of business on September 30, 2020. At this quarterly dividend rate, the annual dividend is equivalent to \$1.68 per common share.

The Board of Directors also declared the following:

- A regular quarterly dividend of \$894.444 per share (equivalent to \$8.94444 per depositary share) on the Series A Non-Cumulative Perpetual Preferred Stock of U.S. Bancorp, payable October 15, 2020, to stockholders of record at the close of business on September 30, 2020.
- A regular quarterly dividend of \$223.61 per share (equivalent to \$0.22361 per depositary share) on the Series B Non-Cumulative Perpetual Preferred Stock of U.S. Bancorp, payable October 15, 2020, to stockholders of record at the close of business on September 30, 2020.
- A regular quarterly dividend of \$406.25 per share (equivalent to \$0.40625 per depositary share) on the Series F Non-Cumulative Perpetual Preferred Stock of U.S. Bancorp, payable October 15, 2020, to stockholders of record at the close of business on September 30, 2020.
- A regular quarterly dividend of \$321.88 per share (equivalent to \$0.32188 per depositary share) on the Series H Non-Cumulative Perpetual Preferred Stock of U.S. Bancorp, payable October 15, 2020, to stockholders of record at the close of business on September 30, 2020.
- A regular quarterly dividend of \$343.75 per share (equivalent to \$0.34375 per depositary share) on the Series K Non-Cumulative Perpetual Preferred Stock of U.S. Bancorp, payable October 15, 2020, to stockholders of record at the close of business on September 30, 2020.
- A regular semi-annual dividend of \$662.50 per share (equivalent to \$26.50 per depositary share) on the Series J Non-Cumulative Perpetual Preferred Stock of U.S. Bancorp, payable October 15, 2020, to stockholders of record at the close of business on September 30, 2020.
