Therefore, movements from Magnolia, Arkansas to Finney, Louisiana and Haynesville, Louisiana will be made only as operating conditions require or allow so as not to discriminate against any Shipper, and in accordance with Item No. 130 of Carrier’s Tariff F.E.R.C. No. 2.0.0, and successive issues thereof. Reversal of the pipeline to accommodate deliveries from Magnolia, AR to Finney, Louisiana and Haynesville, Louisiana will be done based on operating conditions, and only after the full tender in progress has been delivered to its tendered destination.
