Dear Secretary Reese:

In accordance with the requirements of the Interstate Commerce Act (“ICA”) and the Rules and Regulations of the Federal Energy Regulatory Commission (“FERC” or the “Commission”), in particular Section 342.3, 18 C.F.R. § 342.3 (2024), SALA Gathering Systems, LLC (“SALA”) submits for filing the following tariffs, to be effective July 1, 2025:

FERC No. 3.17.0, canceling FERC No. 3.16.0 (Docket No. IS25-51-000)
FERC No. 4.17.0, canceling FERC No. 4.16.0 (Docket No. IS25-51-000)
FERC No. 5.17.0, canceling FERC No. 5.16.0 (Docket No. IS25-51-000)

The rates in each of the above tariffs are modified in accordance with the tariff rate indexing provisions of 18 C.F.R. § 342.3. Each new rate is equal to the corresponding new ceiling level calculated in accordance with 18 C.F.R. § 342.3(d) using the index multiplier of 1.019976 set by the Commission on May 16, 2025 in Docket No. RM93-11-000 for the period from July 1, 2025 through June 30, 2026.¹

In accordance with the requirements of 18 C.F.R. § 342.3(b), Schedule A hereto sets forth the proposed new rates, the prior rates, the prior ceiling levels, and the applicable ceiling levels.
