1. THACKER PASS PROJECT CONSTRUCTION SITE ADDRESS:

Thacker Pass Project (Delivery Gate #8A) 23045 Kings River Road, Orovada, NV 89425

The GPS Coordinates for Gate 8A (Delivery Gate entrance) is 41.694870, -118.034469

Approximately 18 Miles Northwest of Orovada, NV on State Route 293

2. RECEIVING HOURS (PACIFIC STANDARD TIME):

Monday – Saturday 8:00 AM – 3:00 PM Other Times by prior arrangement ONLY

3. DRIVING DIRECTIONS:

Starting from Orovada, Nevada near mile 43.6 on State Route 95:

- Upon arrival in Orovada, Nevada, turn onto State Route 293 near the Sawtooth Shell Gas Station.
- There is a public K-8 school within a short distance from the intersection of State Route 95 & State Route 293. The Nevada speed limit for school zones is 15-mph. Please remember to control your speed and watch for young children during the appropriate hours of the day!
- Continue on State Route 293 north towards Thacker Pass, for approximately 18 miles (just past Nevada Mile Marker 18).
- The turn off to the delivery gate is on the right side of State Route 293.
- ALL vehicles MUST stop at the Security checkpoint for site orientation and further instructions.



4. DRIVER AND CONSIGNMENT DETAILS

ALL DELIVERIES REQUIRE APPOINTMENTS.

Request to deliver to the Thacker Pass Project jobsite must be made at least 24 hours prior to the estimated time of arrival. The request must be made via email to Emerson Spence at espence@bechtel.com. The request must be approved prior to delivery.

The email request should include the following information:

- Project identification (Thacker Pass Project Construction Site)
- Expected delivery date and time
- Name and contact details of the Contracted Trucking Company.
- Driver's name and contact details (cell number)
- Vehicle License Plate Number
- · Carrier Bill of Lading
- Vendor packing list, Safety Data Sheet (if applicable) and any other shipment document relevant to the shipment.

4.1 Personal Protective Equipment (PPE) Requirements:

ALL drivers are required to have the following PPEs for access into the Project Site:

- Hard Hat
- Steel Toe Boots
- Clear Safety Glasses
- Long pants and long-sleeved shirt (no shorts or cut-off shirts)
- Hi-Viz vest
- Gloves, cut level 4, or greater, with impact protection

4.2 Speed Limits

Drivers must observe all speed limits including the speed limit of the Orovada School zone. The speed limit on Thacker Pass Project Jobsite property is 15 mph.

^{*}Trucks are NOT allowed to hold over at the Security Gate. Trucks are NOT allowed to park overnight near the Security Gate or the jobsite premises. The nearest truck stop/RV park is the Sawtooth gas station at the corner of State Route 95 and State Route 293.
